15 min	Presentation/Demo - OASIS COEL TC (Classification Of Everyday Life)	Joss Langford	<ul style="list-style-type: none"> <li>• Joss presented an overview of the COEL Standard taxonomy and structure. Gave a demo of how this might look for management of consents.</li> <li>• It is quite useful for personal data store applications</li> <li>• Q: Who is using COEL? A: Apps that are analysing behaviors, for example in wearables space. Also IoT space - it allows recording of what people actually do, not what they say they do. Pseudo-Anonymization is critical.</li> <li>• Q: Who controls the pseudonymization?
